Discussion Item 4 - Board Composition

Michael Meidel reiterated the number of reappointments, as mentioned above, and highlighted resignations and the decision not to fill vacancies left by Kay McKenzie in the Business sector and Samuel Kolapo in the Workforce sector. This reduces the size of the Board to 29 members, which follows Federal and State law. Manny Bhuller has decided not to extend to another term and on June 22, a replacement will be appointed since 51% Board membership is required. Scott Thomas, HR Director at a local Healthcare facility, is the nominee who will come before the BCC for appointment. Michael Ramsey will be replaced by another representative of St Petersburg College, of which public higher education is required. Michael Meidel announced his resignation due to retirement and will be replaced by Kevin Knutsen, the Interim Director of Economic Development, for this required Economic Development seat on the Board. Michael Meidel suggested that the reappointment of the 13 Board members be added to the Board agenda in May for approval. Barclay Harless agreed with this suggestion and indicated that Michael Meidel's input on these items will be missed. Michael Meidel indicated that he has trained up staff members to cover these items moving forward.

Action Item 8 - PY'2021-2022 Board Officers Recommendations

WorkNet Pinellas, Inc. dba CareerSource Pinellas Bylaws, Article V, Sections 1 and 3 states:

SECTION 1 – Election of Officers

The Chair, Chair Elect, Treasurer, and Secretary of the CareerSource Pinellas Board shall be elected as follows:

- A. The slate of Officers shall be recommended to the CareerSource Pinellas Board of Directors by the Ad-Hoc Nominating Committee and selected based upon a majority vote of the quorum present at the annual meeting at which the slate is presented.
- B. The annual meeting at which the slate of Officers shall be elected shall take place in June or on a date as otherwise set by the Board, and the Officers shall take office in July.
- C. The CareerSource Pinellas Chair, Chair Elect and Treasurer shall be selected from among the representatives of the private sector Board members.

SECTION 3 - Terms of Office

The term of office for the Chair, Chair Elect, Secretary and Treasurer of CareerSource Pinellas shall be for one (1) year, from July 1 through June 30.

CareerSource Pinellas Officers may serve two consecutive terms of one year each in the same office, if reelected, provided that the time in office does not exceed the limits of their term of membership on the Board. After two consecutive terms, the Officer shall then step down from their position for a minimum of one year, although they may continue to serve as CareerSource Pinellas Board members, or in other offices.

The Vice Chair is not subject to the Officer term limits specified herein.

WorkNet Pinellas, Inc., dba CareerSource Pinellas, Bylaws, Article V, Sections 1 and 3 states:

SECTION 1- Election of Officers

The Chair, Chair Elect, Treasurer, and Secretary of the Board shall be elected as follows:

- A. The slate of Officers shall be recommended to the Board of Directors by the Ad-Hoc Nominating Committee and selected based upon a majority vote of the quorum present at the annual meeting at which the slate is presented.
- B. The annual meeting at which the slate of Officers shall be elected shall take place in June or on a date as otherwise set by the Board, and the Officers shall take office in July.
- C. The CareerSource Pinellas Chair and Chair Elect shall be selected from among the business representatives.

SECTION 3 – Terms of Office

The term of office for the Chair, Chair Elect, Secretary and Treasurer of CareerSource Pinellas shall be for one (1) year, from July 1 through June 30.

CareerSource Pinellas Officers may serve two consecutive terms of one year each in the same office, if re-elected, provided that the time in office does not exceed the limits of their term of membership on the Board.
